

Who owns the Moroccan subsoil?

Until now, two local giants have reigned unchallenged over the Moroccan subsoil: OCP Group, the phosphates giant, which is 95% state owned, and Managem, a subsidiary of the royal holding company Al Mada, which produces gold, silver, cobalt, copper, zinc and lead, and is headed by Imad Toumi.

Is the Mont Tropic underwater lithium deposit a threat to Morocco?

The Mont Tropic underwater lithium deposit, located near the border with Mauritania and the Canary Islands, is believed to be one of the largest strategic mineral reserves in Africa. Exploiting it would require mining groups prepared to take high geopolitical and environmental risks, even if these would necessarily be shared with Moroccan groups.

Should Morocco lift the moratorium on underwater mining?

At the last International Seabed Authority (ISA) conference in Kingston, Jamaica from 24 to 28 July, Morocco was one of the African states most in favour of lifting the moratorium on underwater mining. A sign that the kingdom is interested in developing these strategic metal deposits off its southern coast.

Are Al Mada & OCP working on a mining project in Morocco?

Some material could come from Moroccan subsoil and as such, royal holding company Al Mada and OCP, allied with North American investors including Québécois Benoît La Salle, are quietly working to develop mining projects. Mining entrepreneur Benoît La Salle can't believe his luck.
