Northvolt, the Swedish electric battery manufacturer, is facing a major financial crisis, burdened with \$5.84 billion in debt. The company announced Thursday evening that it has filed for protection under the U.S. Chapter 11 bankruptcy law, aiming to restructure its finances and ensure its survival in an increasingly competitive market.

US-based liquid metal battery firm Ambri's Chapter 11 bankruptcy and recent sale of assets to a consortium of its lenders was covered by Energy-Storage.news last week. The firm's technology is based around liquid calcium anodes and molten salt electrolyte.

Small-scale energy storage manufacturer Electriq Power filed for Chapter 7 bankruptcy on May 3, 2024, and has now engaged with Moecker Auctions to liquidate over \$18 million in assets. Electriq Power was founded in Silicon Valley in 2014. Last year, the manufacturer merged with publicly traded acquisition company TLGA.
