What are the Greek (general) product safety provisions?

The Greek (General) Product Safety provisions, namely the above Decision and article 7 of Law 2251 (enacted at the time when the previous Directive 92/59/EEC was in force and still being applicable) impose on suppliers the obligation to put into circulation only safe products.

Can a Greek QE claim a civil sanction?

As of 26 June 2023,a representative action for injunctive measures brought in Greece by a Greek QE may include an additional claim for compensation as civil sanction,which may be awarded only once for the infringing practice challenged.

Can a non-Greek person Sue a Greek court?

As a rule,any person,either Greek or non-Greek,is subject to a Greek court's jurisdiction,thus he may sueor be sued,provided a Greek court is locally competent to try the case (article 3 of GCCP).
