Which batteries are exempt from the batteries act?

Portable batteries for emergency or alarm systems including emergency lighting, medical equipment and cordless power tools are exempt from this prohibition. For the purpose of collection, the Batteries Act differentiates between portable, industrial and automotive batteries.

Are commercial batteries exempt from the 2024 National Defense Authorization Act?

It is noted that this regulation is part of the "2024 National Defense Authorization Act," passed on December 22,2023. However, commercial purchases, such as Ford's procurement of batteries from CATL in Michigan and Tesla's sourcing of batteries from BYD, are temporarily exemptfrom these measures.

Can Chinese batteries be used in the US? There have been several political efforts to restrict the use of Chinese-made batteries in the US.

The Batteries Act prohibits the placing on the market of batteries containing more than 0.0005 percent of mercury by weight. It is also prohibited to place on the market portable batteries containing more than 0.002 percent of cadmium by weight.
