## Lead-acid battery electrolytic lead

What is a lead acid battery?

A lead acid battery consists of electrodes of lead oxide and lead are immersed in a solution of weak sulfuric acid. Potential problems encountered in lead acid batteries include: Gassing: Evolution of hydrogen and oxygen gas. Gassing of the battery leads to safety problems and to water loss from the electrolyte.

How does a lead-acid battery work?

The lead-acid battery consists negative electrode (anode) of lead,lead dioxide as a positive electrode (cathode) and an electrolyte of aqueous sulfuric acid which transports the charge between the two. At the time of discharge both electrodes consume sulfuric acid from the electrolyte and are converted to lead sulphate.

What are the advantages of lead acid batteries?

One of the singular advantages of lead acid batteries is that they are the most commonly used form of battery for most rechargeable battery applications(for example,in starting car engines),and therefore have a well-established established,mature technology base.

What are the different types of lead acid batteries?

There are two major types of lead-acid batteries: flooded batteries, which are the most common topology, and valve-regulated batteries, which are subject of extensive research and development [4,9]. Lead acid battery has a low cost (\$300-\$600/kWh), and a high reliability and efficiency (70-90%).

What are the problems encountered in lead acid batteries?

Potential problems encountered in lead acid batteries include: Gassing: Evolution of hydrogen and oxygen gas. Gassing of the battery leads to safety problems and to water loss from the electrolyte. The water loss increases the maintenance requirements of the battery since the water must periodically be checked and replaced.

Can lead acid batteries be used in commercial applications?

The use of lead acid battery in commercial application is somewhat limitedeven up to the present point in time. This is because of the availability of other highly efficient and well fabricated energy density batteries in the market.

Lead and lead dioxide, the active materials on the battery"s plates, react with sulfuric acid in the electrolyte to form lead sulfate. The lead sulfate first forms in a finely divided, amorphous state and easily reverts to lead, lead dioxide, and sulfuric acid when the battery recharges.

The lead acid battery uses lead as the anode and lead dioxide as the cathode, with an acid electrolyte. The following half-cell reactions take place inside the cell during discharge: At the anode: Pb + HSO4 -> PbSO4 + H+ + 2e-. At the cathode: PbO2 + 3H+ + HSO4- + 2e- -> PbSO4 + 2H2O. Overall: Pb + PbO2 + 2H2SO4 -> 2PbSO4 + 2H2O.

Two electrons are released into lead electrode. As electrons accumulate they create an electric field which attracts hydrogen ions and repels sulfate ions, leading to a double-layer near the surface. The hydrogen ions screen the charged electrode from the solution which limits further reactions unless charge is allowed to flow out of electrode.
