When does a battery warranty start?

For batteries purchased on pro-rata warranty settlement discount, a fresh warranty is applicable from the date of purchase.

What is the warranty on Exide Batteries?

The label on every Exide battery specifies the total number of months covered by the free replacement period and the Pro-Rata period for batteries fitted in private cars, multi-utility vehicles*, two-wheelers, inverters, gensets and solar applications. In all cases the warranty is applicable from the date of sale to the original purchaser.

How do you recondition a lead acid battery?

To recondition a lead acid battery, follow these steps (Step-By-Step Guide): Combine the cleaning solution ingredients. Clean the battery cellsby removing any rust. Fill the battery cells with water. Replace the electrolyte in the battery. Recharge the battery. Check the battery voltage and load.
