

How do I Mark a lithium battery?

The lithium battery mark is required as specified in the DGR. The border of the mark must have red diagonal hatchings with a minimum width of 5mm. The symbol (group of batteries, one damaged and emitting flame, above the UN number for lithium ion or lithium metal batteries or cells) must be black on white or a suitable contrasting background.

Can a lithium battery Mark be printed directly on the packaging?

The lithium battery mark may be printed directly on the outer packaging provided that there is sufficient contrast between the elements of the lithium battery mark and the colour of the packaging material. The mark must be in the form of a rectangle or a square with minimum dimensions of 100 mm x 100 mm.

Where can I find the lithium battery marking and labeling guidelines?

You can find the lithium battery marking and labeling guidelines inside Section 7 of the latest copy of the Dangerous Goods Regulations (DGR) or the Lithium Battery Shipping Regulations (LBSR). What do the Lithium Battery Marks and Labels Look Like? The lithium battery mark is required as specified in the DGR.

What are the dimensions of a lithium battery Mark?

Section 5.2.1.9 requires the dimensions of the lithium battery mark to be a minimum 120 mm wide and 110 mm high unless the "the package size so requires, the dimensions/line thickness may be reduced to not less than 105 mm wide and 74 mm high."

What is a lithium ion battery Mark?

The mark is also widely used on packages of consumer electronic devices such as cellular phones, notebooks, tablets, and power tools that are packed with or contain lithium ion batteries.

Do I need a lithium battery Mark?

The Model Regulations require the lithium battery mark in section 5.2.1.9 and shown below to be placed on nearly all packages containing small lithium ion and lithium metal cells and batteries when shipped in accordance with Special Provision 188.

Non-rechargeable batteries with more than 2 grams of lithium (eg "C" size battery and above) are forbidden in any baggage and must be presented and carried as Cargo in accordance with the IATA Dangerous Goods

In accordance with Special Provision A201, lithium metal cells or batteries that meet the specified quantity limits may be shipped on a passenger aircraft under an approval issued by the authority of the State of Origin, State of Destination and State of the Operator.

What Labelling and Marking is required to Send a Package of Lithium Batteries? All lithium battery shipments must be clearly labeled and marked appropriately according to IATA regulations. No matter which marks or labels are required, lithium battery labeling and marks must be placed on the packages or overpacks so they are not obstructed. They ...
