How long does a battery warranty last?

In addition to this, proof of correct battery usage is required when making a battery warranty claim. For a 10% surcharge on the net price for products that came with a 5-year warranty, an additional 5 years of warranty can be purchased, bringing the total warranty to 10 years.

How long does a battery last?

Exceptions on this are: lead-acid batteries; 2 years from date of purchase by the end-user, with a maximum of 30 months from the Victron Energy invoice date, Lithium batteries; 3 years from date of purchase by the end-user. In addition to this, proof of correct battery usage is required when making a battery warranty claim.

What is the new battery regulation?

The Regulation entered into force on 17 August 2023 and repeals the Batteries Directive (Directive 2006/66/EC). It continues to restrict the use of mercury and cadmium in batteries and introduces a restriction for lead in portable batteries. It also aims to: reduce environmental and social impacts throughout the entire battery life cycle.

When did the EU adopt a battery regulation?

Parliament approved the agreed text on 14 June 2023. The regulation was published in the EU Official Journal on 28 July 2023. Procedure completed. The issue of batteries is relevant to many policy areas, from transport, climate action and energy to waste and resources.

Why should batteries be regulated in 2020?

The global demand for batteries is increasing rapidly and is predicted to have a 14-fold increase by the year 2030. To minimise the environmental impacts of this growthand considering changes in society,new technological developments,markets and the uses of batteries,the European Commission proposed a new Batteries Regulation in 2020.

How long does a victron energy warranty last?

Warranty extensions need to be applied for ultimately one yearbefore the expiration of the original term.
