Is battery storage a key component of the energy transition?

Battery storage is also seen as a key component of the energy transition--the global goal of achieving net-zero carbon emissions by 2050--as power grids adapt to using renewable, yet unpredictable and intermittent, sources of energy such as such wind and solar.

How big is the battery storage market?

The battery storage market is growing in tandem with electric vehicle use. Australian energy research company Aurora Energy predicted in Europe alone the sector will attract over EUR70 billion of investment by 2050.

What was the biggest battery storage deal in 2018?

Although 2018 had a far greater total deal value, this was due to the largest battery storage deal on record, Brookfield Business Partners and Caisse de dépôt et placement du Québec 's \$13.2 billion acquisition of Clarios, a global leader in the sector.

How much is a battery storage deal worth?

PE deal activity for battery storage companies reached a peak last year, with 80 deals announced worth a combined \$11.2 billion, according to PitchBook data.

China's Contemporary Amperex Technology Co (CATL), the world's largest battery maker, raised \$6.7 billion in a private placement, marking the second-largest equity capital markets transaction in the world so far in 2022..
