#### What is the warranty start date of solar modules?

The warranty start date of the Solar Modules stipulated under this Limited Warranty for Solar Modules (hereinafter referred to as "Limited Warranty") is the date of delivery to the Initial Customer or 6 monthsafter the modules are shipped out of the production plant, whichever is earlier (hereinafter referred to "Warranty Start Date").

### How long is the warranty on the solar panels?

#### What if a model is returned to JA Solar?

If the MODULES will be returned to JA Solar for inspection, repair or replacement by JA Solar, JA Solar shall provide the Customer with a Return Merchandise Authorization (RMA). However, JA Solar will not accept a return of any MODULES without such RMA.

### Can a limited warranty be transferred?
