## Tender for island pumped energy storage project

The European Investment Bank (EIB) has approved a EUR300 million (\$327 million) loan to finance the construction of the Salto de Chira pumped-storage hydroelectric power plant being built by Red Eléctrica, a subsidiary of Redeia, in Gran Canaria.

The project includes the construction of a pumped storage hydroelectric power station with a capacity of 200 MW in turbine mode and 220 MW in pumping mode, a seawater desalination plant and the associated ...

They would encompass electricity production, energy storage and desalination, including pumped storage hydropower technology. The subsidies would be from the Decarbonization Fund for islands. The ambition is to tackle both water shortages and electricity supply.
