

What is a lead acid battery?

The lead acid battery is traditionally the most commonly used battery for storing energy. It is already described extensively in Chapter 6 via the examples therein and briefly repeated here. A lead acid battery has current collectors consisting of lead. The anode consists only of this, whereas the cathode needs to have a layer of lead oxide,  $PbO_2$ .

Can lead acid batteries be used in commercial applications?

The use of lead acid battery in commercial application is somewhat limited even up to the present point in time. This is because of the availability of other highly efficient and well fabricated energy density batteries in the market.

Are lead acid batteries corrosive?

However, due to the corrosive nature of the electrolyte, all batteries to some extent introduce an additional maintenance component into a PV system. Lead acid batteries typically have coulombic efficiencies of 85% and energy efficiencies in the order of 70%.

What are the advantages of lead acid batteries?

One of the singular advantages of lead acid batteries is that they are the most commonly used form of battery for most rechargeable battery applications (for example, in starting car engines), and therefore have a well-established, mature technology base.

Do lead acid batteries need to be sulfated?

Periodic but infrequent gassing of the battery to prevent or reverse electrolyte stratification is required in most lead acid batteries in a process referred to as "boost" charging. Sulfation of the battery.

Can a lead acid battery fail?

The battery may also fail as an open circuit (that is, there may be a gradual increase in the internal series resistance), and any batteries connected in series with this battery will also be affected. In principle, lead-acid rechargeable batteries are relatively simple energy storage devices based on the lead electrodes that operate in aqueous electrolytes with sulfuric acid, while the details of the charging and discharging processes are complex and pose a number of challenges to efforts to improve their performance.

Lead batteries operate in a constant process of charge and discharge. When a battery is connected to a load that needs electricity, such as a starter in a car, current flows from the battery and the battery then begins to discharge.
